IF THIS HAPPENS: DO THIS:									
Tanker/Vehicle Accident:		Switch off engine and electrical equipment. Keep people away and warn other traffic. Check for spills and leaks. Call the emergency services: Dial 111. If major spill occurs, evacuate all personnel upwind.							
Spill or Leak:	environme Wear prote	<b>Major spills: Call the Fire Department and alert them to the nature of the spill.</b> Prevent further migration into the environment. Prevent spilled material from flowing onto adjacent land or waterways. Use suitable material to solidify liquid. Wear protective equipment including eye protection. Large spills due to traffic accidents, etc., should be reported immediately to CHEMCALL.							
Fire:		<b>Call the Fire Department: Dial 111.</b> Wear protective clothing and breathing apparatus. May release toxic fumes under fire conditions. Use foam, fog, powder or CO2 (see Spill or Leak section above). Consider evacuation of the immediate area.							
FIRST AID									
If Swallowed:	-	NEVER give anything by mouth to an unconscious person. Harmful if swallowed. Do NOT induce vomiting. Immediately call a POISON CENTRE (0800 764 766) or doctor/physician. If medical advice is needed, have product container or label at hand.							
If in Eyes:		Wash eyes cautiously for 15 minutes. Remove contact lenses if they are present and it is easy to do so. Continue rinsing. Immediately call a Poison Centre or doctor/physician.							
If on Skin:		Immediately flush body and clothing with large amounts of soap and water, using safety shower if available. Quickly remove all contaminated clothing and footwear. Seek medical advice.							
If Inhaled: Remove to fresh air and keep at rest in a position comfortable for breathing. If ill effects persist, contact doctor or poison centre for advice.								r poison
