Tanker/Vehicle Accident:	Switch off engine and electrical equipment. Keep people away and warn other traffic. Check for spills and leaks. Call the emergency services: Dial 111. If major spill occurs, evacuate all personnel upwind.
Spill or Leak:	Major spills: Call the Fire Department and alert them to the nature of the spill. Wear overalls, chemical resistant gloves, boots and safety googles. Prevent further spillage. Absorb spilled product and place in sealable container for disposal. Wash down affected area with water and detergent. Absorb and collect washings and place in the same sealable container. Dispose of container according to the regulations of the local authority.
Fire:	Call the Fire Department: Dial 111. Wear protective clothing and breathing apparatus. May release toxic fumes under fire conditions.
